Bids seeking online rates from Scheduled Commercial Banks (PSU Banks and Private Banks) have also been uploaded on [www.ambedkarfoundation.nic.in](http://www.ambedkarfoundation.nic.in) and [www.socialjustice.gov.in](http://www.socialjustice.gov.in). In response to the said EoI, sealed envelopes containing the quoted rates may be dropped in the tender box placed at the Reception of Dr. Ambedkar International Centre, 15 Janpath, New Delhi-110001, latest by 19/1/2026 by 2:00PM. The validity of the quoted rates should be for a minimum period of 15 days or upto the date of revision of policy rate by RBI whichever is earlier.

(d)	Term deposits of the bank shall not be less than Rupees Twenty-Five Thousand Crore (Rs.25,000 crore)
(e)	At least 5 years from the commencement of Banking business in India
